 Included with Rental: We include the use of the 3 barns and a large parking area for your
wedding and use as you see fit. We also offer chairs to seat up to 250 (Max) guests.
We have 5 - 4 ft. round tables, 6 - 6ft. rectangle tables, & 6 -8 ft. rectangle tables for use as well.
Trash cans are included, but must be emptied and disposed of by you. (trash liners not included)
 Hours of Rental: Friday 9:00 a.m 9:00 p.m., Saturday 8:00 a.m 12:00 p.m., Sunday 9:00 a.m
2:00p.m. <b>Note:</b> Thursday's can also be used with prior approval if you need more time.
 Rental Payment Due: ½ of rental fee + \$250 damage deposit(refundable at check out if property
is left in good clean condition) down date of signed agreement. Remaining Balance is due 1 week
before wedding date. Non-Refundable if cancelled less than 4 weeks in advance.
Forms of Payment Accepted: Check, Cash, Credit Card
 Weather Contingency: (backup) plan for outdoor wedding: There are 3 barns on the premises
that the wedding ceremony and/or reception can be moved into if inclement weather occurs.
 No alcohol is permitted on the grounds.
 Catering and Food Prep: There is not a prep kitchen on the grounds at this time and limited
electrical availability. Please make sure they know this in advance when planning how to serve
food.
 Heat and Air: There are fans in the red barn loft and patio heaters available, but NO propane
fuel is included. Please be aware.
 Linens etc.: We do not have linens, plates, silverware. If you wish to have them rental contact
will follow or you may bring your own.

	<b>Restrooms:</b> No restrooms on the premises at this time. Rental contact for port-a-potty			
	follows.			
	<b>Decorations:</b> Please do not hang anything from the walls or ceilings with any type of			
	permanent fasteners or make holes without approval. Please let us know 1 week prior to			
	wedding if anything like this is needed.			
	Sparklers/Fireworks: They are permitted with prior approval. Please let us know if you plan			
	to have any potentially dangerous items on the premises.			
	Parking: We have a parking sign beside the turn into the field for parking. You and your			
	guests may ONLY park in the field or on the gravel. Please do not park in any grass/yard areas.			
	<b>Sound System/DJ:</b> Please note we do not provide a sound system or provide a DJ for events.			
	<b>Dressing Rooms:</b> We do not have a changing area for the wedding party at this time.			
	Damage Deposit: Please make sure all grounds and barn areas are clean and free of any trash			
	or debris. Recycling when you can is encouraged. Your \$250 deposit will be refunded at Check			
	out to ensure grounds and barns are left clean. **Empty trash cans and dispose of all garbage.

### **FACILITY RENTAL AGREEMENT**

THIS FACILITY RENTAL AGREEMENT ("Agreement"), effective as of the day of, 20, by and between ACRES OF GRACE FARMS, LLC, 2258 Henson Road, Red Boiling
Springs, Tennessee 37150 (hereinafter referred to as "Acres of Grace") and
(insert name), (insert address) (hereinafter referred to as "Using Party").
WITNESSETH:
WHEREAS, Acres of Grace is the lessee of certain real property and facilities in Clay County, Tennessee, located at 2258 Henson Road, Red Boiling Springs, Tennessee 37150 known as Acres of Grace Farms, LLC ("Premises"); and
WHEREAS, Using Party is desirous of renting the Premises, and Acres of Grace is desirous of allowing Using Party to sublet the Premises upon the terms and conditions as contained herein.
<b>NOW, THEREFORE,</b> in consideration of the foregoing and the further consideration of the covenants, agreements, and obligations as contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:
1. <b>TERM/DATES OF USE:</b> Using Party is authorized to use the Premises on the following dates and times:  (insert dates). These dates and times may be extended only by mutual written agreement of the parties. It shall be Using Party's sole responsibility to notify Acres of Grace if additional dates or time are needed and, assuming Acres of Grace approves such additional dates or times, Using Party shall pay Rent as provided herein for such additional dates or times, which shall include any and all time Using Party, or any of its guests, invitees, agents, clients, or employees is making use of the Premises.
2. <b>RENT:</b> The total rent for the term of this Agreement shall be as follows:

\$ will be due to hold your date. The remaining amount will be due 2 weeks prior to
the event.
A \$ cancellation fee will be charged for rental, if cancelled before two weeks prior to the event date. Rent is payable two weeks prior to the event and shall be made payable to Acres of Grace Farms, LLC, 2258 Henson Road, Red Boiling Springs, Tennessee 37150, Attention: If cancelled within two weeks of the event day, the cancellation fee will be
3. USE OF PREMISES: Using Party shall use the Premises only for the following purposes:  (insert description of use). Using Party represents and acknowledges that it will not use Premises for any illegal activities or any other purposes as designated in this
Paragraph.
4. <b>CONDITION OF PREMISES:</b> Using Party stipulates, represents and warrant that it has examined the Premises, and that it is at the time of this Agreement in good order, repair, and in a safe, clean, and rentable condition and suitable for Using Party's intended use. Using Party will clean the Premises and return the Premises to Acres of Grace in as good a condition as when received or arrange with Acres of Grace for said cleaning at the expense of Using Party, as provided in Paragraph 5.
5. <b>ALTERATIONS:</b> No alterations, additions, or improvements shall be made by Using Party to the Premises without the prior consent of Acres of Grace.

6. **INDEMNIFICATION:** Acres of Grace shall not be liable for any damage or injury of or to the Using Party, or its, his or her property, or guests, invitees, agents, clients, or employees, of their property, or any theft



thereof, and Using Party agrees to indemnify, defend, and hold Acres of Grace harmless from any and all claims or assertions of every kind and nature arising out of Using Party's use of the Premises, including, without limitation, the attorney fees and costs of Acres of Grace.

- 7. **INSURANCE:** Acres of Grace requires that it be added as an Additional Insured on a primary basis under Using Party's Commercial General Liability policy. If the Using Party does not have a Commercial General Liability policy, then as a condition to using the Premises, Acres of Grace requires that Using Party obtain a Special Events policy for the dates Using Party will be using the Premises. A minimum general liability limit of \$1,000,000 per occurrence/\$2,000,000 aggregate is required. The required insurance may be in the form of blanket insurance policies and may be provided by so-called umbrella coverage. A copy of the certificate of insurance from the Using Party naming Acres of Grace as an Additional Insured on a primary basis shall be given to Acres of Grace at least one (1) week before the rental date.
- 8. Using Party's personal property of every kind which may at any time be in the Premises shall be at Using Party's sole risk, and Acres of Grace shall not be liable for any damage to said property or loss suffered by the Using Party.
- 9. **LIQUOR LICENSE:** In the event Using Party's authorized use under this Agreement shall in any way involve the sale, serving or furnishing of alcoholic beverages by or to Using Party or its guests, invitees, agents, clients, or employees, for which a liquor license of any kind is required by federal, state of local laws and regulations, Using Party shall, prior to being allowed possession of the Premises under this Agreement, provide verification that said license is and remains in full force and effect and has not expired or otherwise been suspended, cancelled or revoked. In addition, Using Party shall further be required to obtain, at its sole cost and expense, appropriate liquor liability insurance that provides coverage for any loss caused by or arising out of Using Party's sale, serving or furnishing of alcoholic beverage by or to Using Party or its guests, invitees, agents, clients, or employees, and Using Party shall name Acres of Grace as an additional primary insured on said policy(ies) of insurance and shall provide Acres of Grace with certificate of the respective insurers specifying that the required liquor liability insurance is in force and effect and that Acres of Grace is an additional insured.
- 10. **ASSIGNMENT:** Using Party shall not assign this Agreement or sublet the Premises, or any part thereof, with the prior written consent of Acres of Grace.
- 11. **MISCELLANEOUS.** This Agreement constitutes the entire agreement between Acres of Grace and Using Party; this Agreement shall be construed in accordance with the laws of the State of Tennessee; the provisions of this Agreement shall be binding on and inure to the benefit of the parties, their legal representatives, heirs, successors and permitted assigns; and this Agreement shall not be amended, altered, or changed, except by a written documents signed by the parties. This Agreement may be executed in any number of counterparts, including by facsimile, and each such counterpart shall constitute an original and all such counterparts shall constitute one and the same document.
